- ❖ As per the letter received from North-Eastern Hill University, College Development Council Shillong, No.CDC/C.16/Misc/2014/IV/-2120 dated the 11<sup>th</sup> February,2019 to formulate Internal Committee for the students with disabilities in colleges, the meeting was held by the PwD Committee, Shillong College, on the 28<sup>th</sup> February 2019, had a thorough discussion and proposed relevant information.
  - Letter was issued to the different departments of the college to help identify students with different types of disabilities.

- ❖ As per the letter received from North-Eastern Hill University, College Development Council Shillong, No.CDC/C.16/Misc/2014/IV/-2120 dated the 11<sup>th</sup> February, 2019 to formulate Internal Committee for the Students with Disabilities in University/Colleges, the meeting was held by Equal Opportunity Cell the on the 28<sup>th</sup> February 2019, had a thorough discussion and decided to issue letters to the different departments of the college to help identify students with different types of disabilities.
- ❖ In a meeting held on 26.03.2019, the Equal Opportunity Cell has decided to include the disabled Students, their parents and Smt. Larisa Hek (College nurse) as members of the Committee in order to address the needs of the students effectively. The Committee has decided to convene a meeting with the students and their parents at the earliest. Further, the Committee from time to time impress upon the college authority to create barrier free infrastructure and encourage enrolment of such needy students with relaxation admission criteria.
